17. STILES (Minute No. 78.4 refers)

- a) The Landowner of Footpath Nos. 2,3 and 4 has confirmed that he would not wish to see kissing gates installed as stiles are much safer for livestock.
- b) The Landowner of Footpath No. 5 has still not contacted either the SCC Public Rights of Way (PROW) Officer or the parish council. The PROW Officer had established that "as highway authority they have the power or right to maintain, alter or remove any structure of work on, over or under land that neither belongs to the highway authority, nor forms part of a highway for which we are the highway authority. In relation to section 291 "structure" includes a bridge, fence, barrier or post and 'work' includes tunnel, ditch, gutter, watercourse, culvert, drain, soakaway or pipe. The word structure does not seem to indicate that we can enter land to repair a stile which doesn't really help in this situation."

The PROW Officer asked whether an approach to the NFU may help to see if they can get the Landowner to contact either him or the parish council. The Clerk contacted the NFU, but they said that "unfortunately we would not be able to assist in this matter. Due to data protection legislation, we are not able to confirm whether the Landowner is a member of the NFU or not." The Clerk has relayed the NFU's response to the PROW Officer with a request as to how this matter can now be progressed.

18. CORRESPONDENCE

18.1 Meadow View (Minute No. 81.4 refers)

The resident was informed of the council's decision to install "no dogs in the play area" signs, noted that the area is covered by a Byelaw and that it is not possible to patrol the area due to the additional costs involved in so doing. The resident has responded saying that the Byelaw is ignored by many users and he believes that the council's actions "will have no effect whatsoever".

18.2 Tree issue – Walkway from Station Road to Meadow View (next to the post box)

A resident contacted the council expressing concern about the size and stability of the above tree, suggesting that its height needs review and capping at a suitable height.

The Clerk contacted the tree surgeon and asked that he visit the site to assess the tree and quote for any remedial works that might be necessary. The tree surgeon recommends that the Silver Birch tree have a 40% height reduction and small reshape – removal of the tree is unnecessary. The following quotation has been received:

- Reduction in height by 40%
- Small crown re-shape and reduction also
- All debris removed from site and area left tidy

Total cost: £335.00

18.3 Shotwood Close Public Open Space

Bryan Chinn contacted the council on behalf of the Shotwood Close Residents Association regarding tree works recently undertaken on the Public Open Space and asking what had prompted the council's decision to fell one of the trees. An explanation was provided to Mr Chinn.

Mr Chinn also mentioned that residents had commented that it is impossible for children to run among the trees on the Public Open Space due to branches being near the ground and he asks if the council plans to "coppice" the trees to a suitable height for children to run under them.

PUBLIC FORUM

No questions or comments were put to the council.

POLICE

PCSO Evans introduced himself to the council and spoke to the Crime Statistics Report previously provided to Councillors. The report showed an overall decrease in crime of 30% this year compared to 2018. The biggest reductions were:

- More serious violent crime with injury: -100%
- Arson: -60%
- Personal robbery: -50%

Councillors raised the issue of people littering gas cannisters around the village, specifically at the Craythorne Road car park and Elizabeth Avenue. Youths were also reported hanging around the street at Elizabeth Avenue. Councillors also raised the issue of youths congregating in their vehicles at the Craythorne Road car park and dropping fast food litter from their vehicles and not using the litter bin, causing unnecessary work for the council's contractor. PCSO Evans said that he would continue to visit both sites and that he would also speak to people in their cars to remind them not to drop litter.

Councillors asked for an update on the recent break-ins at the Scouts HQ and the Cricket Club. PCSO Evans said that both cases have gone to the Resolution Centre.

70. MATTERS ARISING

Minute Nos. 11 and 52 - Tractor

It was noted that this had not been progressed and that the council would need to take over this project as the Youth Representative was now going to University. See Minute 77(a)

71. ENVIRONMENT COMMITTEE

- 71.1 **RESOLVED** That the Minutes of the Environment Committee meeting held on 12 August 2019 be approved as a true record.
- 71.2 Councillor S McManus reported that the Committee had met for a second time on 02 September at slightly different issues had been put forward. He asked the council to consider whether the Committee should be either a committee of the council or a new village group reporting to the council. Councillor S McManus said that the new group would need Terms of Reference and governance/funding would need to be put into place.

RESOLVED THAT:

- a) The committee be a new village group chaired by the Parish Council Chair.
- b) Councillor S McManus write the Terms of Reference, etc for the group
- c) A small amount of funding be made available to the group in a similar manner as operated for the Station Heritage Group.

72. COUNTY COUNCILLOR'S REPORT

Councillor White reported that:

- The Shobnall Road works had been completed on time
- The Burton railway station bridge was taking a little longer than anticipated to complete due to issues encountered during the works

Councillor S McManus asked for an update on the College Field Village Green application. Councillor White said that the Countryside and Rights of Way Panel meeting will take place on 20 September and he will make a presentation to that meeting. He said that the recommendation is to refuse the application and a final decision will be made at the Panel meeting.

73. BOROUGH COUNCILLOR'S REPORT

No report was available.

74. PARISH COUNCILLORS' REPORTS

74.1 Councillor Wyatt:

a) He had noted the increase in tree and vegetation growth around the road signs and that the 40mph sign was now in the hedge. He asked if the council's contractor could be asked to clear the road signs in the interests of safety.

AGREED That the contractor be requested to clear the road signs.

b) Knowles Hill – growth onto the road from the hedge on the right hand side of the road is a potential road safety hazard. He asked if the council's contractor could be asked to cut the hedge back.

AGREED That the contractor be requested to cut the hedge back from the road.

c) Craythorne Road car park – there were potholes which need to be filled to prevent potential damage to users' vehicles.

AGREED That the contractor be asked for his view on the condition of the car park and for his quotation to fill the potholes.

- 74.2 Councillor Sanderson said that he was now Vice Chair of the Almshouse Committee (he is RPC's nominated representative on the committee).
 - A Station Road resident had reported a persistent bonfire nuisance which prevents people from having their windows open on warm evenings/nights. On the Clerk's advice, the resident had obtained the relevant forms from ESBC and she was looking for other people to come forward who were affected by the bonfires.
 - The overgrown hedge on Station road, which had not been cut for around 14/16 months, had been reported to Staffordshire Highways (Ref. No. 4170804).
 - The log was still in the brook contractor to be chased to deal with this as soon as possible.
 - Signs had appeared on the Spread Eagle island railings contractor to be asked to remove these.
- 74.3 Councillor Badcock referred to the longstanding problem of flytipping which was accruing on the path adjacent to the Craythorne Road playing field. The Clerk had previously reported the problem to ESBC on several occasions. Councillor Badcock said that he had contacted ESBC and they had displayed signs asking the landowner to contact them. The landowner had come forward and said that he would remove the rubbish but two weeks later it is still there and in fact it is being added to. He asked that Borough Councillor Toon be asked to take this up at ESBC and try to get this sorted out as soon as possible. He said that he would continue to chase this up with ESBC.

AGREED That Borough Councillor Toon be asked to take this matter up at ESBC.

74.4 Councillor Stewart reported that the Willow tree at 4 Beacon Road was overhanging the road and footway and needs to be cut back.

AGREED That the householder be requested to cut the tree back.

76. COMPLETION OF AUDIT FOR THE YEAR ENDED 31 MARCH 2019

Councillors were informed that the External Auditor had signed off on the audit for the year ended 31 March 2019 and that no issues had been raised for the council's attention. The Completion Notice and full Annual Governance and Accountability Return had been displayed on the council's website as required under the current Regulations.

RESOLVED That the above be noted.

77. ACTION POINTS

a) Tractor (see also Minute No. 70)

It was noted that the Youth Representative had now left the council as he was starting University and it therefore fell to the council to resolve this matter.

RESOLVED THAT:

- i) Councillor Gooding be requested to liaise with his contacts at the Pumping Station so that the tractor can be moved there and works undertaken to make it suitable for installation into a play area.
- ii) Consideration be given to the location where the tractor will be installed.

b) Village Map (see also Minute No. 78.2)

Councillors considered whether a claim should be made on M&B for the map and frame to be replaced at their cost. Councillors agreed that, as the council could not provide evidence of the map and frame being undamaged prior to it being removed, this matter would be not progressed. The Clerk informed the council that M&B were arranging for the frame to be repainted at their cost as soon as possible.

c) Allocation of village areas to councillors

It was agreed to leave this in abeyance as the new village environmental group were keen to be involved with monitoring areas of the village.

d) Exploration of a new allotments site: To be added to Action Points.

78. ROLLESTON FOOTPATHS

78.1 Footpaths Leaflet

Councillor Stewart gave update on progress to date, adding that she was working with Clive Baker who had provided the artwork for the previous version. Mr Baker had offered to do the artwork free of charge but would welcome a donation towards the cost of the software. Councillor Stewart asked if it was necessary to include the footpath distances on the new leaflet.

RESOLVED THAT:

- a) A donation be made to Mr Baker towards the cost of software.
- b) Footpaths distances be removed on the new version of the footpaths leaflet except for the longer footpaths which take walkers to Tutbury.
- c) Comparative quotations be sought by Mr Baker and Councillor Wyatt for print runs of 2000 and 3000 quantities of the leaflet.
- d) A copy of the leaflet be distributed to every household with the Rollestonian.

78.2 Village Map

Mr Baker agreed to prepare a revised version of the Village Map for the council's approval.

78.3 Footpath Walks

Councillors Stewart and Wyatt confirmed that all the footpaths had been walked.

78.4 Stiles

The Clerk provided a comprehensive report giving an update on progress to date, including comparative quotations for metal and timber kissing gate options. Councillors felt that it would be beneficial to install some kissing gates if contributory funding could be accessed from the County Council's Community Paths Initiative.

RESOLVED THAT:

- a) The report be noted.
- b) The landowner of Footpath Nos. 2, 3 and 4 be contacted and asked if he would be amenable to kissing gates being installed instead of simply replacing the existing stiles.
- c) An update be provided to the next council meeting.

79. 2019 RoSPA REPORTS

The RoSPA play safety inspection reports for the council's four play areas had been circulated to all councillors. Councillors were generally pleased with the reports. Councillor S McManus undertook to write up the tasks to be completed and this list would then be provided to the council's contractor to enable to quote for those works.

RESOLVED THAT:

- a) Councillor S McManus write up the tasks to be completed, as set out above.
- b) The bolt on the Craythorne Road goal be replaced as soon as possible.
- c) The fence at the Elizabeth Avenue play area be welded as soon as possible.

80. COLLEGE FIELDS: \$106 AGREEMENT

It was noted that Councillor Gooding had asked for this item to be included on the Agenda for consideration but as he was absent from the meeting it was agreed that this item be deferred.

81. CORRESPONDENCE

81.1 Walford Road: Request for a gate to alley

The council had been contacted by a resident of Walford Road with two dogs who enjoy walking in the fields in the village. The resident says that "Unfortunately, there have been a few occasions when they have run from the far side of the field, through the alleyway, onto the road at the top of Walford Road. This is a risk to them and any passing motorists or cyclists. I have spoken to other dog owners and some of them have experienced a similar problem with their dogs. This could be easily resolved with the installation of a gate, similar to the one leading onto Beacon Road from the fields."

RESOLVED That the requested gate be included in the list of works to be undertaken on footpaths/stiles.

81.2 Marston Lane: Litter bin request

A resident who voluntarily regularly collects litter in the village has requested that a litter bin be installed at the parking area next to the river.

RESOLVED THAT:

- a) The request be agreed provided that ESBC will regularly empty the bin.
- b) A bin was required ½ along the Jinny Trail but ESBC had previously said that their vehicles could not access the site to empty the bin, therefore a bin had not been installed. It was noted however that there is a bin at the Stretton end of the Trail and ESBC were to be contacted to ask if they emptied this bin and if so they were to be asked to confirm that if RPC were to install a bin they would regularly empty it.
- c) ESBC to be contacted to ask (i) what its policy is on the provision of recycling bins and (ii) to ask if they will install recycling bins around the village, or at least at the Craythorne Road Car Park and at the Co-op.

81.3 Damage around the village

A resident had contacted the council to report:

Brook Hollows: The perimeter fence/edging next to Brook Hollows by the side of The Lawns road bridge is damaged. The Clerk had reported this to ESBC who said that an Officer would be sent to investigate the problem.

Brookside: The cobbled kerb in Brookside, near to Brook House, is damaged and is missing stones. The Clerk had reported this to Staffordshire Highways via its online reporting tool on 30 July.

RESOLVED THAT:

- a) The above reports be noted.
- b) ESBC to be informed that a bin was leaning at Brook Hollows.

81.4 Meadow View

The following has been passed to the parish council by ESBC. A resident of Meadow View had contacted ESBC expressing his concerns with the number of dogs running freely in the park where children are playing, and he thought better patrolling and signage should be used to reduce the risk to children. The resident also asks if the play area could have a sign suggesting stronger penalties for people not having their dogs on leads at all times. He stressed that something needs to be done.

Best Kept Village Competition 2019

Thank you for taking part in this year's BKV competition. I hope that you achieved what you set out to do and applaud you for making the efforts which you did. It's very rewarding to achieve 'top honours', but the real philosophy behind BKV is for villages to take part and to get their community working together to maintain or improve the appearance of their village.

We had 41 entries this year, which is much the same as last year. A number of villages, who entered regularly in the 1980's and 1990's, have dropped out of BKV for various reasons in recent years. I think that is a shame and The Community Foundation will be doing all it can to encourage new entries in 2019 and I would be really pleased to see more in 2020.

The 'Best' villages were separated by just a few marks again and judges felt that overall standards were very good indeed. The Judge's comments, which are attached to this letter will show you where you did particularly well this year, but also where you could make improvements for 2020. I hope you will find the comments fair, constructive and helpful. If you have any questions or comments on the comments please contact Jo Cooper at The Community Foundation.

The BKV Working Group, which organises the BKV Competition on behalf of The Community Foundation will meet in November to look forward to next years BKV competition. So, if you have any comments or suggestions about the format of the BKV Competition please let Jo Cooper know at The Foundation, preferably before the end of October. Do you think that there should be any changes to the various elements to be judges or to the judging areas, for instance?

We are only about to run the BKV Competition with the help of out volunteer judges. There were nearly 70 this year in Rounds 1 and 2 and we are always looking for new judges. So, if you know of anyone who might like to be a BKV Judge please ask them to contact Jo Cooper. We offer two interesting days visiting some of Staffordshire's pleasant villages, good company, lovely pubs for lunch and perfect weather! We provide training for all new judges and it's not rocket science!

Finally. This has been my last year as Chairman of the BKV Working Group. I shall step down with many happy memories of the villages which I have visited over the years and the many wonderful BKV volunteers I have met all over the County. I wish the BKV Competition every good fortune in future and hope that it continues to develop as it has over the past 64 years. I shall continue as a judge, so perhaps we will meet again in your village sometime between May and June next year!

Thank you for your continued interest and involvement in BKV. I hope that you will enter again 2020 and do well in the competition. If you would like a meeting to discuss BKV in general or any aspect of the judge's comments, please get in touch with The Community Foundation.

JUDGES COMMENTS 2019 ROLLESTON ON DOVE

BKV awareness was achieved through articles in the parish council newsletter, in the village magazine, the Rollestonian, on the village website and Facebook page. However, judges did not find any BKV posters displayed in the village, despite the entry form stating that they could be found in 5 locations.

The entry form indicated that children's posters would be displayed at 6 locations, but very few were actually seen. It would have helped if the locations had been marked on the map.

In May the notice boards were in good condition with neatly displayed notices. In June, the school notice board was clean and tidy, as were the notice boards in Burnside and in Bodecliffe Road and at Craythorne playing fields. The glass was smashed in the notice board at the Co-op.

There was some parish information and a few activities were advertised on the church notice board, but there was nothing about groups or contacts in the village on any of the boards and no recycling or dog fouling information.

The churchyard had been well mown on both judging visits. In May cuttings had been left on the path, probably because mowing was taking place at the time! Graves were well tended and the bench at the front of the church was in good condition. Two benches at the rear of the church were covered in lichen and needed a wash down. There were two good notice boards. At the front of the church there was an 'ugly-bug' display made by the local children which the June judges liked.

The village hall is within the grounds of the church and was maintained to a very good standard.

In May The Spread Eagle public house and The Jinny were clean and litter free. The hanging baskets at the Spread Eagle needed attention. In June some litter was found at the Spread Eagle, but apart from that, the surrounds were tidy. The Brookside Hotel was closed in June.

The telephone box (not included on the entry form) was tidy and in a good condition in May, but in June judges commented "that it was very dirty both inside and out and generally in a poor condition".

In May all the bus shelters were in good condition. May judges liked the milepost seat in the shelter opposite The Spread Eagle. June judges liked the shelter and notice board with parish council information at Dovecliff Road, but it needed a sweep out. June judges liked The Spread Eagle shelter with its small notice board (bus timetable but no other information) and lovely planters. The Church Road shelter was dirty with lichen in June.

Seats and benches were in reasonable condition and free from weeds and litter. The seats opposite the Spread Eagle and in the Elizabeth Avenue play area were particularly good, but some of the other seats and benches will need attention soon.

Three village features were noted on the entry form, but their locations were not shown on the map. May judges assumed that the village sign, the anvil and memorial area were the three features stated. The planter near the anvil contained one plant only and the area under the trees needed a lot of attention. June judges commented on the area opposite The Spread Eagle, which was tidy, fenced off and picturesque, with a bus shelter and finger post.

The large public open spaces were, in general well maintained. The grass at Craythorne playing fields was well mown, and an area was laid out as a football pitch. There was some litter here in June. Brook Hollows was a delightful conservation area in June, with no litter. The Jinny nature trail was another pleasant conservation area with a good notice board showing local information. The Jubilee Orchard was litter free. Both May and June judges had some difficulty in locating the open spaces as they were not clearly identified on the map.

All the incidental open spaces were neat and tidy, litter free and the grass appeared to have been cut regularly.

Most private gardens were well maintained, and those that were not appeared to be at vacant properties.

The children's play equipment and safety surfaces were in good condition and generally well maintained. The slide at Elizabeth Avenue would benefit from a coat of paint.

The map did not make life easy for the judges. It provided them with the bare bones of the village and was sufficient to find their way around the village. It could be greatly improved by showing exactly where all the BKV elements to be judged are located, relating those to the numbers on the entry form and showing them by means of colored symbols and key numbers. There are many good examples of BKV maps which you could look at. Please contact The Community Foundation if you would like to see such a map or if you would like a member of the BKV Working Group to advise you.

Judges found Rolleston on Dove generally very clean and tidy, with very little litter and no dog fouling. June judges commented "we found its unique treatment of water delightful. It is a very attractive village which we will visit again". It was difficult to discern from evidence on the ground the extent of community awareness and involvement. The entry pack contained information on the village's excellent preparation for entry into the BKV competition. Meetings had been held seeking to involve all the residents in preparing the village for judging. A BKV children's poster competition was publicized by the Parish Council and the winning posters were an important part of the village's BKV entry. Sadly, this initiative did not translate well to what appeared on the ground. No BKV posters were see and very few children's posters. It was a shame that such worthwhile efforts that had been made in preparation for the competition did not materialize "on the ground".

It is good to see Rolleston on Dove entering the Best Kept Village competition after a break of 20 years. Lessons can be learned from the experience this year. With a good map, plenty of BKV and children's posters and attention to detail, Rolleston on Dove could shine in the competition in the future and perhaps challenge for top honors soon. If the Parish Council wished to discuss the comments and seek further advice on how things could be improved for next year, please contact Jo Cooper at The Community Foundation and arrange a date for a meeting. Thank you for entering the competition this year and for making a good first impression. We hope to see you in 2020.
